

SUBJECT: Petroleum Infrastructure Best Permitting Practices Hearing

I attended your hearing in Martinez yesterday but was unable to stay until it ended so that I could introduce myself. I am very interested in the work you and your colleagues have undertaken regarding the obstacles to prompt permitting of pipelines and other petroleum infrastructure.

For quite a few years, our office has supported the need for this type of review. The State Fire Marshal is not a "permitting" agency so we find ourselves in a position of recognizing a significant problem without being able to take any type of leadership role in solving the issues. (While we do not issue permits, we do have authority to "close" a pipeline until safe operations can be assured.) The difficulties pipeline companies have encountered in getting permits for pro-active repairs and replacement pipeline segments has caused our staff many headaches over the past few years. With the aging infrastructure of the current pipeline systems and continued growth of heavily urbanized areas that conflict with once-rural pipeline right-of-ways, we anticipate that the problem will only continue to worsen until a solution is developed.

The purpose of this letter is to offer our continued support of your initiative to examine the permitting practices currently in place and develop a plan for streamlining the processes.
