

Purpose of Workshop

The Electricity Committee is seeking the participation of the California Independent System Operator (CA ISO), the state's major investor-owned and municipal utilities, (including Pacific Gas & Electric, Southern California Edison (SCE), San Diego Gas & Electric (SDG&E), Los Angeles Department of Water & Power and Sacramento Municipal Utility District) and other interested parties in this workshop. The Electricity Committee requests the CA ISO, utilities, and other interested parties to provide their supply and demand outlooks for the summer 2005 and comment on the Energy Commission staff's outlook.

The Electricity Committee specifically requests the Energy Commission staff, CA ISO and major utilities present their demand forecasts (peak and energy) for the summer 2005, as well as any demand forecasts they previously prepared for the summers of 1999 through 2004. The Electricity Committee would like all presenters to be prepared to discuss methodologies or approaches for making weather adjustments to their forecasts. In addition, the Electricity Committee requests that Energy Commission staff, CA ISO, and utilities present historic summer peak and energy demand for the summers of 1999 through 2004 to allow for a meaningful comparison of forecasts and actual demand for individual utilities and geographic regions in the state.

Background

The *Draft Summer 2005 Electricity Supply and Demand Outlook* was presented to the Senate Energy Committee on February 22, 2005, where the Energy Commission committed to hold a Committee workshop to seek stakeholder input on the summer 2005 outlook and forecast methodology and compare the historical demand forecasts with actual demand levels observed.

The *Draft Summer 2005 Electricity Supply and Demand Outlook* provides the current California Energy Commission (Energy Commission) staff assessment. It evaluates the capability of the electricity system to provide power to specific geographic areas in California to meet expected electricity demand.

Energy Commission staff expects that electricity supplies will be adequate statewide to meet growing demand and the required seven percent operating reserves under average (1-in-2 or 50 percent probability) temperature conditions.

However, Energy Commission staff has concluded that Southern California (south of Path 26 or SP26) will have insufficient resources to meet electricity demand and maintain a seven percent reserve during very hot weather (1-in-10 or 10 percent probability) this summer. The focus is on those portions of Southern California served by the CA ISO including SCE, SDG&E, and CA ISO participating municipal utilities.

The Electricity Committee requests participants to provide their input either orally at the workshop or through written comments. The Staff Draft Report is available on the

Energy Commission website [http://www.energy.ca.gov/2005_summer_outlook]; and, by March 16, 2005, an agenda for the workshop will also be posted on the website.
