

I am writing to inform you that Federal Power Company, LLC, through its subsidiary Federal Power Kings County, LLC, purchased Duke Energy Avenal, LLC, the owner of the Avenal Energy Project. Duke Energy Avenal, LLC has been renamed Federal Power Avenal, LLC. Therefore, Federal Power Avenal, LLC is now the owner of the Avenal Energy Project and will be the entity responsible for the conditions of certification applied to the project if the California Energy Commission licenses the project.

Federal Power Avenal, LLC plans to continue the licensing of the Avenal Energy Project upon obtaining a power purchase agreement. Due to the recent long term solicitation by Pacific Gas and Electric Company and draft solicitation issued by Southern California Edison Company, we anticipate proceeding with the project in the next year or so depending upon the time required to finalize the solicitations.

Federal Power Avenal, LLC assumes responsibility for the truth and accuracy of the Application for Certification and subsequent data responses filed in this proceeding to date.
