# Notice of Availability of 15-Day Language

The 15-Day Language for the proposed new and amended regulations on the petroleum data collection is available for comment.

### **Background**

On December 3, 2004, the Energy Commission published a Notice of Proposed Action (NOPA) concerning the potential adoption of new and amended regulations on petroleum data collection requirements, along with the text of the proposed regulations (45-Day Language) and an Initial Statement of Reasons describing the rationale for the proposed changes. On March 16, 2005, the Energy Commission published revised regulations (15-Day Language) and a notice of a hearing to adopt the proposed regulations. On April 13, 2005, the Energy Commission adopted the proposed regulations and subsequently submitted them to the Office of Administrative Law.

On August 8, 2005, the Office of Administrative Law denied the proposed regulations based on the following deficiencies:

- 1. Failure to comply with the Clarity and Reference standard of Government Code section 11349.1 in three of the proposed regulations:
  - 1365.2, Emergency Reporting
  - Appendix C, Section III, Electronic Maps
  - Appendix A, Subdivision 2, Weekly Reporting
- 2. The regulatory filing omitted reference citations in 13 of the proposed regulations.
- 3. Materials referenced in the proposed regulations were not referenced correctly and/or not included within the text of the regulations:
  - References to other Administrative Codes
  - Copies of the proposed reporting forms and instructions
- 4. The regulatory file does not contain all required documents, and/or required documents included in the file were defective:

- The Notice of Proposed Rulemaking (45-Day Notice) was not provided to the Office of Administrative Law
- The Statements of Mailing did not conform with the requirements applicable to mailing
- A referenced report (Energy Information Administration Report "Accuracy of Petroleum Supply Data) was not listed in the original notice
- A 15-day comment period should have been allowed for the change made to section 1366 (k) on April 13, 2005. This change clarified reporting requirements for major petroleum marketers

The Energy Commission has revised the proposed regulations to address the deficiencies identified by the Office of Administrative Law and placed all required documents in the regulatory file, specifically:

- Transcript of the April 13, 2005, Hearing to Adopt the proposed regulations

In addition to these new documents, the original notice, proposed regulations, initial statement of reasons, final proposed regulations submitted to the Office of Administrative Law, Final Statement of Reasons, and the Decision to Disapprove the

proposed regulations from the Office of Administrative Law, are available in the regulatory file.

Last, at the April 13, 2005 Business Meeting, the Energy Commission adopted the proposed regulations with a request that an amendment be made limiting the reporting requirements for major marketers to those who are required to file the Form EIA 782B published by the United States Department of Energy. The Office of Administrative Law determined that the Energy Commission must provide 15-day comment on this amendment. Comments on this amendment are also invited during this comment period.

Copies of the proposed regulations adopted on April 13, 2005, the Final Statement of Reasons, and the Decision to Deny the Proposed Regulations are also available at the same site.

#### **Written Comments**

The Energy Commission is accepting written comments on matters raised in the Decision of Disapproval made by the Office of Administrative Law. Comments will be accepted until September 30, 2005.
