Proposed Amendments to Appliance Efficiency Regulations

Dear Commissioners Pfannestiel and Rosenfeld:

On behalf of our client, Lexmark International, Inc., I write to express support for the proposed amendment to the Commission's appliance efficiency regulations. Lexmark makes it easier for businesses and consumers to move information between the digital and paper worlds. Since its inception in 1991, Lexmark has become a leading developer, manufacturer and supplier of printing and imaging solutions for customers in more than 150 countries. Founded in 1991, Lexmark reported \$5.3 billion in revenue in 2004.

As originally enacted, the appliance efficiency regulations could have resulted in several possible negative outcomes. Lexmark would have to discard a large number of replacement part external power supplies currently on hand, complete an expensive and time consuming redesign process, or manufacture and stockpile a large number of replacement parts before the applicable deadline. The proposed amendment, however, allays these concerns.

Specifically, Lexmark supports the revised deadline applicable to external power supplies found on page 131, Section 1605.3 u (1).

Power supplies that are made available by a product manufacturer as accessories, service parts, or spare parts for its products manufacture red prior to July 1, 2006 shall be exempt from the requirements in Table U-1 and Table U-2 until June 30, 2009.

Power supplies that are made available by a product manufacturer as accessories, service parts, or spare parts for its products manufacture red between July 1, 2006 and December 31, 2007 shall be exempt from the requirements in Table U-2 until December 31, 2010.

Consumers occasionally need a spare or replacement part for a Lexmark product they have previously purchased. Extending this timeline will make it easier for Lexmark to provide spare or replacement parts to consumers who have already purchased our products.
