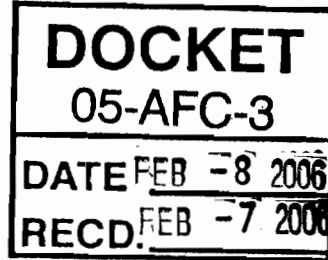

**PUBLIC PARTICIPATION IN THE REVIEW OF THE SUN VALLEY ENERGY PROJECT (05-AFC-3)**

On December 1, 2006, Valle del Sol, LLC, (the applicant) filed an Application for Certification (AFC) for its proposed Sun Valley Energy Project. A copy of this AFC was previously provided to this library. Enclosed with this cover letter is a copy of supplemental information to the AFC. Staff at the California Energy Commission has reviewed these supplemental materials for data adequacy. On February 1, 2006, the Energy Commission decided, with the supplemental information, that the application is now complete. The Energy Commission has begun the data discovery and analysis phases of the licensing process. These phases will include a number of public workshops and hearings. An Informational Hearing and Site Visit is scheduled for February 27, 2006, to be held at the Eastern Municipal Water District Board Room, Perris, CA. A separate public notice of this event will be issued.

The Energy Commission is responsible for reviewing and ultimately approving or denying all thermal electric power plants, 50 MW and greater, proposed for construction in California. The Energy Commission's facility certification process carefully examines public health and safety, environmental impacts and engineering aspects of proposed power plants, and all related facilities such as electric transmission lines, natural gas pipelines, etc. The Energy Commission's responsibilities are similar to those of a lead agency under the California Environmental Quality Act (CEQA).

Over the next year, the Energy Commission will conduct a number of public workshops and hearings on the proposal to determine whether the project should be approved for construction and operation and under what set of conditions. These workshops and hearings will provide the public and local, state, and federal agencies the opportunity to ask questions about and provide input on the proposed project. The Energy Commission will issue notices for these workshops and hearings, normally 14 days, but not less than 10 days, prior to the meeting.
