The California Energy Commission (Energy Commission) and the California Public Utilities Commission (CPUC) will conduct a joint workshop to discuss the role of affordable housing in the Energy Commission's New Solar Homes Partnership and the CPUC's California Solar Initiative (CSI) incentive program. Commissioner John Geesman is the Presiding Member, and Vice Chair Jackalyne Pfannenstiel is the Associate Member of the Energy Commission's Renewables Committee, which is assigned to develop the New Solar Homes Partnership. President Michael Peevey is the Assigned Commissioner for CSI, and Commissioner Dian Grueneich is the Assigned Commissioner for low-income issues at the CPUC.

Purpose

The Energy Commission and CPUC are embarking on a 10 year solar initiative to achieve 3,000 megawatts (MW) of solar power in California by 2016. Both Commissions are committed to including the affordable housing market in this state effort.

This workshop provides a forum for both the Energy Commission and the CPUC to receive stakeholder input on how components of our respective programs should be structured to best fit the affordable housing community's needs.

Background

In January 2006 the CPUC adopted Decision 06-01-024 establishing the CSI with the goal of creating a sustainable solar market in California. This decision states that the CPUC will implement a solar incentive program that addresses the non-residential and existing housing markets. Decision 06-01-024 and the Joint Staff Proposal for the general building markets can be found at:

[http://www.cpuc.ca.gov/static/energy/solar/_index.htm]. The CPUC intends to develop a proposed affordable housing component by this fall, with final action in early 2007.

Decision 06-01-024 recognized the Energy Commission's intent to implement a solar incentive program for the new residential market. The Energy Commission's *Draft Staff Proposal on the New Solar Homes Partnership* (Draft Staff Proposal) describes the goals, rationale, and elements of the New Solar Homes Partnership, concentrating on the production homes market with no detail at this time on the affordable housing market. Both the Energy Commission and the CPUC recognize that California's housing industry and affordable housing communities have interests that may span the market segments that each of the agencies intends to target in their respective solar programs. Beyond this joint workshop, the Commissions recognize that more coordination may be necessary to establish highly effective programs. The Commissions may elect to hold additional joint workshops or proceed with individual forums better suited to structuring the affordable housing elements of each program.
