

This is a follow up to earlier conversation concerning San Diego Gas & Electric Company's (SDG&E) Application for Confidential Designation (Application). This Application was submitted to the Energy Commission on June 15, 2006, pursuant to the California Code of Regulations, Title 20, section 2505, and seeks confidential designation of various information included in SDG&E's CEC-SEP-3 (Utility) Data Request for SEP Application submittal. This submittal includes the completed CEC-SEP-3 form as well as supporting Excel Spreadsheets and SDG&E's Advice Letter 1795-E.

As I indicated, I have reviewed SDG&E's Application with Energy Commission staff and need additional information as identified below in order for the Energy Commission to fully evaluate the Application. This information is requested pursuant to Title 20, section 2505 (a)(3)(A).

#### Information Provided in CEC-SEP-3 Form

Question 6 - Contract Price.

SDG&E requests that contract price information reported in Question 6 of the CEC-SEP-3 form be kept confidential for "a period of three (3) years," but does not indicate when this three-year period is to begin. Does the three-year period begin on the date the Energy Commission approves the Application (assuming it is approved), on the date the underlying power purchase contract with Esmeralda Truckhaven Geothermal, LLC, (Esmeralda) is approved by the California Public Utilities Commission, or some other date. Please indicate in your response the beginning and end dates for the three-year period.

SDG&E requests that various contract pricing information included in the Excel spreadsheets entitled "Input Bid Data," "Results," "Contract Price," "Bid Price," "Weighted Average Contract Price," and "Bid Data Request Transfer Sheet" be kept
