Project Location: The San Francisco Electric Reliability Project (SFERP) is located on a 4-acre parcel south of 25th Street and approximately 900 feet east of Illinois Street in the Potrero District of the City and County of San Francisco.

County: San Francisco

Project The SFERP will consist of a nominal 145-megawatt (MW) simple-cycle plant, using three natural gas-fired General Electric LM 6000 gas turbines and associated infrastructure. Construction of the SFERP, from site preparation and grading to commercial operation, is expected to take approximately 12 months with commercial operation anticipated to begin in mid 2007. The City and County of San Francisco intends to operate the facility 24 hours per day, 7 days per week, for up to 12,000 hours per year total for the three combustion turbines.

On October 3, 2006 the California Energy Commission approved the above-described project pursuant to a regulatory program certified by the California Secretary of Resources under Section 21080.5 of the California Public Resources Code.
