A California Energy Commission Committee is reviewing an Application for Certification (AFC) by Starwood Power-Midway, LLC, to construct and operate a 120 megawatt simple-cycle (peaking) power plant, the Starwood-Midway Energy Project, in an unincorporated area of western Fresno County.
