As part of the December 13, 2006 Business Meeting, the Energy Commission will consider adopting revisions to the Emerging Renewables Program Guidebook (ERP Guidebook) and the Overall Program Guidebook for the Renewable Energy Program (*Overall Program Guidebook*). The current version of the ERP Guidebook was adopted in June 2006 and the current version of the Overall Program Guidebook was adopted in April 2006. The California Energy Commission's Renewables Committee (Committee) recommends the Guidebook revisions pursuant to Public Resources Code section 25747, which authorizes the Energy Commission to adopt substantive changes to

Guidebooks upon providing ten days written notice. Changes shall take effect once approved by the Energy Commission at a publicly noticed Business Meeting.

The Committee is proposing changes to the ERP Guidebook and the Overall Program Guidebook to address the implementation of the Energy Commission's New Solar Homes Partnership pursuant to Senate Bill 1 (Statutes of 2006, Chapter 132, Sec. 4), Senate Bill 1250 (Statutes of 2006, Chapter 512, Sec. 11), and Senate Bill 107 (Statutes of 2006, Chapter 464, Sec. 7). Under these laws, solar energy systems are no longer eligible for funding under the Emerging Renewables Program, but may qualify for funding under the New Solar Homes Partnership or the California Public Utilities Commission's California Solar Initiative (CSI) as provided under those programs. The New Solar Homes Partnership will provide funding for solar energy systems installed on new residential construction, and the CSI will provide funding for solar energy systems installed on existing residential buildings as well as new and existing non-residential buildings. Revisions have been proposed to the current ERP Guidebook to address the following:

- Maintain the current rebate level for fuel cells at \$3.00/watt, and for wind systems at \$2.50/watt for the first 7.5 kW of capacity and \$1.50/watt for incremental capacity above 7.5 kW and less than 30 kW.
- Remove the eligibility of solar energy systems pursuant to Senate Bill 1, Senate Bill 1250, and Senate Bill 107, including removal of the following program elements:
 - Photovoltaic and solar thermal electric technologies
 - Pilot Performance-Based Incentive Program (PBI)
 - Solar Schools Program
 - New Housing sections and the removal of the C-46 (solar) license as an eligible contractor state license for purposes meeting installation requirements
- Update fuel cell standards to supersede American National Standards Institute/Canadian Standards Association (ANSI/CSA) America FC 1-2004 requirement.
- Limit maximum system size so as not exceed 100 percent of consumer's historical energy demand.
- Forms updated to match Guidebook changes.
- Other clarifications of a non-substantive nature.

Revisions have been proposed to the current Overall Program Guidebook to address the following:

- Identify the New Solar Homes Partnership as a program element within the Energy Commission's Renewable Energy Program umbrella.
- Identify the funding available for the Emerging Renewables Program and New Solar Homes Partnership pursuant to SB 1250.
- Clarify definitions and make other non-substantive changes.

Please note that the Energy Commission intends to make additional changes to the Overall Program Guidebook when it revises its other Renewable Energy Program guidebooks to implement changes in the law by SB 1250 and SB 107.


