

Staff-Proposed Errata to NSHP Guidebook

Checklist Summary (continued from page 5 of NSHP Guidebook)

The prospective applicant should read the entire Guidebook to be thoroughly aware of the program requirements prior to applying to the program.

1. How to get reservation funding for a Housing Development Deleted: a Deleted: reservation with 6 or more units installing solar on 50% or more of residential buildings and for Affordable Housing (Eligible for 36 month reservation)

The following information must be provided initially to apply for a reservation for incentives from the NSHP:

- 1. A completed Reservation Application Form (NSHP-1)
- 2. Expected Performance-Based Incentive (EPBI) calculations
- Tentative or final Subdivision map 3.
- 4. Cost Estimate from Energy Commission registered solar retailer to purchase and install system(s),
- 5. Construction Plan-set
- **Energy Efficiency Documentation**
- 7. System Size Justification and Eligible Utility Evidence

By the sixth month of the reservation, builders must provide the following information:

- 1. 6 month Reservation Approval and Update form (NSHP-1.6)
- Equipment Purchase Agreement and Installation Contract
- 3. Build-out schedule
- 4. Payee Data record (STD-204)

By the 24th month of the reservation, builders must provide the final subdivision map.

2. How to get reservation funding for All Other Categories of Housing (Eligible for 18-month Reservation)

The following information must be provided initially to apply for a reservation for incentives from the NSHP:

- 1. Completed Reservation Application Form (NSHP-1)
