PUBLIC PARTICIPATION IN THE REVIEW OF WALNUT CREEK ENERGY PARK FINAL STAFF ASSESSMENT

The enclosed Final Staff Assessment (FSA) contains the California Energy Commission staff's environmental and engineering evaluation of the Walnut Creek Energy Park (WCEP) Project. On November 22, 2005, Walnut Creek Energy, LLC (WCE), a wholly-owned subsidiary of Edison Mission Energy (EME), submitted an Application for Certification (AFC) to construct and operate a nominal 500 megawatt (MW) simple-cycle power plant in the City of Industry. The proposed WCEP site is an 11.48-acre parcel located at 911 Bixby Drive in the City of Industry, Los Angeles County, in an area zoned for industrial uses.

The Energy Commission is responsible for reviewing and ultimately approving or denying all applications for construction and operation of thermal electric power plants, 50 MW and greater, proposed for construction in California. The Energy Commission's facility certification process carefully examines public health and safety, environmental impacts and engineering aspects of proposed power plants, and all related facilities such as electric transmission lines and natural gas and water pipelines. The Energy Commission is the lead agency under the California Environmental Quality Act (CEQA), but produces several environmental and decision documents rather than an Environmental Impact Report.

The Final Staff Assessment (FSA) contains the Energy Commission staff's final environmental and engineering evaluation of the project. Any written comments should be submitted by **May 11, 2007**. The FSA is **not** the Energy Commission's final decision on the proposed WCEP project. The Energy Commission's Committee assigned to the project will conduct one or more hearings to consider and weigh the testimony or comments or recommendations of all interested parties, including Energy Commission staff, the applicant, intervenors, public, City of Industry, and other local, state and federal agencies. The Committee will then issue the Presiding Member's Proposed Decision (PMPD) for consideration by the full Energy Commission. The public, intervenors, local, state and federal agencies are encouraged to participate in these hearings. The Energy Commission will issue notices at least 10 days prior to these hearings.
