

Section 1601. Scope

• • •

(u) Power supplies, which are single voltage external AC to DC and AC to AC power supplies included with other retail products, and single voltage external AC to DC or AC to AC power supplies sold separately, excluding power supplies that are classified as devices for human use under the Federal Food, Drug, and Cosmetic Act and require U.S. Food and Drug Administration listing and approval as a medical device; and consumer audio and video equipment, which are televisions, compact audio products, digital versatile disc players, and digital versatile disc recorders, and digital television adapters.

Section 1602, Definitions

(u) Power Supplies and Consumer Audio and Video Equipment.

"Digital television adapter" means a commercially-available electronic product for which the sole purpose is the conversion of digital video terrestrial broadcast signals to analog NTSC-video signals for use by a TV or VCR.

"STB on-mode" means the appliance is connected to a power-source and fulfills its main function.

"STB standby-passive mode" means the appliance is connected to a power-source, does not fulfill the main function but can be switched into another mode with the remote control unit or an internal signal.
