**COMMENTS OF POWEREX CORP.
ON
PROPOSED DECISION OF COMMISSIONER PEEVEY**

In accordance with Rule 14.6 of the Commission's Rules of Practice and Procedure, Powerex Corp. ("Powerex") hereby submits its comments on the Proposed Decision ("PD") of Commissioner Peevey mailed in the above-referenced proceeding on August 15, 2007.

Powerex is the marketing subsidiary of British Columbia Hydro and Power Authority ("BC Hydro"). Powerex sells power at wholesale in the United States pursuant to market-based rate authority granted by the Federal Energy Regulatory Commission, including supply from competitively-priced qualifying renewable (small hydro, biomass and landfill gas) generation facilities.

Powerex wishes to comment on the scope of information that marketers are required to provide under the proposed GHG reporting and tracking protocols. Powerex believes that only a limited number of fields on a NERC tag are relevant for the purposes of tracking the GHG emission factor associated with a particular transaction (e.g. the Point of Receipt (POR) associated with the generation control area; the Purchasing/Selling Entity associated with the first transmission path inside California; the Point of Delivery (POD) within the state of California, etc.) NERC tags are typically subject to confidential treatment. With reporting

limited only to the necessary fields in the NERC tag, the ARB would reduce any potential conflicts that might arise out of the requirement to report extraneous confidential information.

Powerex also questions that element of the Marketer Reporting Protocol (Attachment A at 4.1) that would require reporting of energy wheeled through California and terminating outside of California. Powerex does not believe there is a need to place an additional reporting burden on marketers when the required information appears to have little or no relevance to California's legitimate interest in tracking, reporting, and reducing GHG emissions associated with electricity consumed and generated in California.
