
In accordance with the provisions of Title 20, California Code of Regulations, the four undersigned entities (collectively, the "Applicant") hereby submit this Application for Certification ("AFC") seeking four separate certifications to construct and operate Ivanpah 1, Ivanpah 2, Ivanpah 3 and their Shared Facilities. Ivanpah 1 is a nominal 100 megawatt facility to be owned by Solar Partners II, LLC. Ivanpah 2 is a nominal 100 megawatt facility to be owned by Solar Partners I, LLC. Ivanpah 3 is a nominal 200 megawatt facility to be owned by Solar Partners VIII. The Shared Facilities for the three solar thermal generation plants will be owned by Solar Partners IV, LLC. The three plants and the Shared Facilities (collectively referred to as "Ivanpah Solar Electric Generating System" or "Ivanpah SEGS") are located in San Bernadino County, California, approximately 4.5 miles southwest of Primm, Nevada. The three plants and the Shared Facilities are located on federal land administered by the Bureau of Land Management.

As an officer of each of the four applicant entities aforementioned, I hereby attest, under penalty of perjury, that the contents of this application are truthful and accurate to the best of my knowledge.
