



> Re: Request for consent of CEC to the Transfer of Ownership Interests in Luz Solar Partners Ltd. VIII.



Dear Chairman Pfanstiel:

Caithness Solar Partners VIII GP, LLC and Caithness Solar Partners VIII, LLC (the "Caithness Partners") own partnership interests in Luz Solar Partners Ltd. VIII ("LUZ VIII"), owner of the SEGS VIII Project near Hinkley, California (the "Project"). Harper Lake Company VIII, a California corporation ("HLC VIII"), Hyperion VIII, Inc., a Florida corporation ("Hyperion VIII") are the other owners of partnership interests in LUZ VIII. HLC VIII and Hyperion VIII are affiliates of FPL Energy, LLC; HLC VIII serves as the Managing General Partner of LUZ VIII.

On July 9, 2007, the Caithness Partners entered into a Purchase and Sale Agreement pursuant to which they agreed to directly transfer all of their partnership interests in LUZ VIII (the "Transfer") to ArcLight Renewco Holdings, Inc. ("ArcLight"), an affiliate of ArcLight Capital Partners, a leading energy investment firm. As your office is aware, SEGS VIII operates as a Certified Renewable Energy Facility under CEC Docket No. 88-AFC-1.

The Transfer will not affect the operations of LUZ VIII in any manner. HLC VIII shall continue to serve as the Managing General Partner of LUZ VIII following the Transfer.

The Caithness Partners hereby request the California Energy Commission to approve the Transfer to ArcLight. We will be happy to provide additional information pertaining to ArcLight or the Transfer as you may request.
