



Re: Victorville 2 Hybrid Power Project, Docket No. 07-AFC-1 --Correction of Error in Primary Records; Submission of New Archaeological Site Records; Revision to Figure 5; Confirmation of <u>Archeological Test Plan; Request for Confidential Designation</u>_____

Dear Mr. Kessler:

On behalf of the City of Victorville (the "Applicant"), we are writing to correct an error in a past submittal in the California Energy Commission ("CEC" or the "Commission") Victorville 2 Hybrid ("VV2") Power Project proceeding. As part of the Application for Certification, William Self Associates ("WSA"), a subcontractor on the Applicant's consulting team, completed 23 Primary Record forms to document its cultural resource assessment for the VV2 project and submitted the forms to the Commission under confidential cover. Subsequently, in preparing material in response to a CEC Data Request, WSA discovered that in its original submittal, the first page of 17 primary records and the first page of an update to a previously recorded site contained the same error: each erroneously described the subject site as being on the east side of the Mojave River, instead of on the west side of the river. WSA has corrected the error and the revised first pages of the 17 corrected Primary Record forms and the first page of the Continuation Sheet updating site SBR-10951H are enclosed.

WSA is also writing to confirm the Applicant's acceptance of the Commission's changes to the archeological test plan for two housing sites (VV2-17 and VV2-19) and a prehistoric site (VV2-23). Under confidential cover, the Applicant submitted a test plan for archeological testing, as required by CEC Data Request Set 1, Nos. 46 - 48, on July 23, 2007. CEC cultural resources consultant Mike Lerch indicated at the August 8, 2007 workshop in Victorville that the Commission finds the Applicant's proposed test plan acceptable, with two minor modifications: (1) offset test units at VV2-17 and VV2-19 in order to excavate one half of the privies and expose the other half (thus leaving the materials in the sidewall intact for further study), and (2) ensure that test excavation reaches a depth of 1.5 meters at VV2-23. The Applicant agrees to

implement the suggested changes, believes that the test plan for the three sites is approved with the two revisions, and will proceed with the archeological testing.

In the August 8, 2007 workshop in Victorville, Mike Lerch also requested that Figure 5, which was submitted under confidential cover in response to CEC Data Request 1, Nos. 29, 38, and 45, be revised to include all previously recorded archeological sites within 1,000 feet of project components (1,000 feet from the centerline of all linears). The revised Figure 5 is enclosed in this submittal.

Mr. Lerch also requested that WSA prepare Archaeological Site Records to supplement 27 of the Primary Records WSA submitted under confidential cover on March 8, 2007 as Appendix E, (State of California DPR 523 Forms) of the Draft Confidential Cultural Resources Assessment Report, Victorville 2 Hybrid Power Project, San Bernardino County, California. Twenty-seven Archaeological Site Records are enclosed in this submittal.

The Applicant requests that the Commission designate the information contained in this submittal as confidential pursuant to 20 C.C.R. Section 2502. In support of its application for confidential designation, we provide the following information:

1(b). Specify the part(s) of the record for which you request confidential designation.

All Primary Record forms, all Archaeological Site Record forms, Figure 5, Maps 1 - 5

2. State and justify the length of time the Commission should keep the record confidential.

The Primary Record forms, the Archaeological Site Record forms, and maps 1-5 of Figure 5 should be kept confidential indefinitely to protect potential cultural resources sites. If the descriptions of the locations of the sites are released to the public domain, there is a risk of looting.

3(a). State the provisions of the Public Records Act or other law that allows the Commission to keep the record confidential, and explain why the provision(s) apply to the record.

The Primary Record forms, the Archaeological Site Records, and maps 1 -5 of Figure 5 specifically identify site locations and areas of potential cultural significance. They are thus protected under Government Code Sections 6254 (e) and 6254(k). Protection provided is analogous to that given to Native American sacred places under Section 6254 (r) of the Government Code.

3(b). Discuss the public interest in nondisclosure of the record. if the record contains trade secrets or its disclosure would otherwise cause loss of a competitive advantage, please also state how it would be lost, the value of the information to the applicant, and the cost or difficulty with which the information could be legitimately acquired or duplicated by others.

The public interest will be served by nondisclosure by preventing looting of the cultural resource sites described in the Primary Record forms and the Archaeological Site Record forms, and depicted in maps 1-5 of Figure 5. Such looting would preclude scientific study of the sites to obtain data about the cultural resource areas.

4. State whether the record may be disclosed if it is aggregated with other information or masked to conceal certain portions (including but not limited to the identity of the applicant). State the degree of aggregation or masking required. If the data cannot be disclosed even if aggregated or masked, explain why.

The Applicant believes CEC staff will require the specific information contained in the confidential version of the Primary Record forms, the Archaeological Site Record forms, and maps 1 -5 of Figure 5 to properly perform its analysis. Aggregation of information would hinder a complete CEC analysis. The Applicant believes, however, that the CEC can incorporate a generalized summary of the information contained in the Primary Record forms, the Archaeological Site Record forma and maps 1 -5 of Figure 5 to properly state the basis for its analysis without disclosing information specific enough to facilitate looting.

5. State how the record is kept confidential by the applicant and whether it has ever been disclosed to a person other than an employee of the applicant. It if has, explain the circumstances under which disclosure occurred.

The Applicant has not disclosed any of the subject information to anyone other than its employees, contractors, attorneys, and consultants working on the VV2 Power Project. It will be marked "Confidential," stored separately from other VV2 Project files, and will be made available on a "need-to-know" basis as determined by a designated representative of the City or its consultants/attorneys/contractors.
