Responses to the 3 additional questions are as follows.

1) Has the cultural resources consultant received a response from the City of Rancho Cucamonga about historic resources listed by city ordinance?

A phone call was made to the City's Planning Department on September 17, 2007. We left a message with the Planning Department Director, Mr. James Troyer. To date, no response has been received from Mr. Troyer.

2) Has the consultant received a response from the County of San Bernardino about historic resources listed by county ordinance?

A phone-call was made to the County Museum on September 17, 2007. Ms. Pam Strunk, with the Raines House (a branch of the County Museum) responded on September 18, 2007 stating that the Museum does not house any additional records regarding cultural resources (she only knows of those available at the San Bernardino Archaeological Information Center [SBAIC]). She offered a contact with the County Community Planning Department for additional information, though according to previous conversations with Chema Ude (in the County Planning Department), the County does not keep these types of records.

3) Has the consultant received any responses from the 11 historical organizations to whom they sent letters asking about historic resources in the project vicinity?

To date no responses have been received from the 11 societies.

Subject:informal questions re San Gabriel cultural resources

Hi Stan,

When I first gave you the Data Adequacy form for the San Gabriel project on May 1, I found the applicant had not provided the required data for two of our regs's specifications for background research. You apparently communicated this informally to their EPM, and in mid-May they sent replacement AFC pages providing, in a preliminary way, the required data. Then I was able to revise my DA form to say they were Data Adequate on May 17.

I am now incorporating that preliminary data in my PSA, but I need to have it updated. So I am hoping you can request a follow-up from their EPM.

Here are the details.

On replacement page 7.3-18, the cultural resources consultant said that they requested information on historical resources listed under some city or county ordinance from the City of Rancho Cucamonga and from San Bernardino County. They then said they had received no responses by the time the replacement pages were sent out to us.

Similarly, on the same replacement page, the consultant said that they sent letters requesting information about local historical resources to 11 local historical societies, but, again, had received no responses by the time the replacement pages were sent.

Clearly, since all this happened within the first two weeks of May, the interval between their asking for information and sending us replacement page 7.3-18 saying that they had received no responses was just too short to reasonably expect responses.

So my questions now are:

1) Has the cultural resources consultant received a response from the City of Rancho Cucamonga about historic resources listed by city ordinance?

- 2) Has the consultant received a response from the County of San Bernardino about historic resources listed by county ordinance?
- 3) Has the consultant received any responses from the 11 historical organizations to whom they sent letters asking about historic resources in the project vicinity?

Please convey my questions to the San Gabriel EPM at your earliest convenience. Thanks.
