Dear Mr. Blevins:

Pursuant to Title 20 of the California Code of Regulations, Solar Partners I, LLC, Solar Partners II, LLC, Solar Partners VIII, LLC, and Solar Partners IV, LLC ( the "Applicant") hereby submits this "Repeated Application for Confidential Designation" pursuant to Section 2505(a)(4) of Title 20 regarding cultural resources for the Ivanpah Solar Electric Generating System.

Section 2505(a)(4) provides that if an applicant's prior application for confidential designation of substantially similar information has been granted pursuant to Section 2505(a)(3)(A), a subsequent application need only contain certification pursuant to Section 2505(a)(1)(G) that the information submitted is substantially similar to the initial application and that all facts and circumstances relevant to the granting or approval of the initial application are unchanged.

By letter dated October 22, 2007, the Commission's Executive Director approved Applicant's request for confidential designation regarding cultural resources. Applicant now wishes to submit in this repeated application for confidential designation, more information regarding cultural resources. The information submitted with this application is substantially similar to the information submitted in Applicant's initial application, and all facts and circumstances relevant to the granting of Applicant's initial application are unchanged.


