MMC ENERGY, INC'S STATUS REPORT

December 17, 2007

MMC Energy, Inc. ("MMC") has submitted responses to California Energy Commission Staff's ("Staff") data requests. MMC provided responses to all but three data requests and filed an object to a fourth data request. Staff requested information on potential system upgrades required to ensure deliverability of power from the Chula Vista Energy Upgrade Project. Because the proposed project to replace the South Bay Power Plant has been withdrawn from the interconnection queue, the congestion on the transmission system will most likely be reduced. MMC is waiting for the California Independent System Operator ("CAISO") to complete a revised deliverability assessment. The CAISO expects to complete this study prior to the end of this year. Once this information becomes available, MMC will provide the revised study to Staff.

Staff also asked a question about a table in the System Impact Study. MMC has requested additional information from San Diego Gas and Electric Company ("SDG&E") to respond to this question from Staff. MMC will provide this information to Staff when MMC receives it from SDG&E.

Staff also asked for a copy of the transmission Facilities Study for the project. MMC will provide this document to Staff when MMC receives it from SDG&E.

MMC continues to work with the city of Chula Vista as well as local entities and groups to discuss the project and listen to any concerns. MMC appreciates the opportunity to keep the Committee informed about the status of this proceeding.
