

From: Craig S. Lease L & L Supplier Inc. Since **1959** Stockton Roofing Company, Inc. Since **1912** 

Regarding: Alternative Testing to **3** year aged Cool Roof Rating Council Requirements. Here is the current proposed language, as follows:

Subdivision (i) and Table 118 A& C Insulation and Roofina Products was amended to reauire aged values for solar reflectance as they become available through the Cool Roof Ratina Council testing. Specified default reflectance and emittance for products that do not have CRRC certification. Added Solar Reflectance Index (SRI) as an alternative to meetina seperate thermal emittance and solar reflectance reauirements.

Alternative testing being: SOLAR REFLECTIVE INDEX as I spoke to the Energy Commission at the December **17**, **2007** 45-Day **Revisions** to Building Energy **Efficiency** Standards-Express Terms, <u>I ask</u> <u>that the above please stav in place</u> as PRI ASPHALT of Tampa Bay Florida I believe has lost our **18** samples of:

1. Heat Shield for Capsheet

2. Heat Shield for Tar and Gravel

We hired PRI Asphalt, Don Portfolio, who did received our **18** samples of our white **cement** roof coating **3** years and 4 months ago, he did the Initial Reflectivity and Initial Emissivity for the **3** year exposure testing, which we received.

Our "Heat Shield Capsheet" scored **85** for Solar Reflectance and **90** for Thermal **Emissivity** "Heat Shield Tar and Gravel scored **81** for Solar Reflectance of **88** for Thermal Emissivity.

Here is what was offered to the Lease's, Craig, Brad and Pat of L & L Suppliers, Inc. Stockton California, by the Cool Roof Rating Council Sept **12,2007.** 

They will leave our current product ratings on the Rated Products Directory for up to six months while we re-start the product rating process for our two CRRC-rated products.

In recognition that our original product samples were misplaced by a CRRC-accredited **body**, they will waive the product rating fees and allow **the** new product ratings to replace the current information, keeping the same product ID numbers."

We asked to make our own samples, as before, as our "Cement Based" formulations dry quickly as you only have so much time, as Heat Shield produces it own heat which aids in drying. This request was agreed to.

We asked for a copy of the handwritten note that was to be faxed to the CRRC by Don Portfolio, which states that he shipped 18 samples of Heat Shield Capsheet and Tar and Gravel to Atlas Weathering of Scottsdale, Arizona.

We have received no note as of now, from Don Portfolio or the CRRC.

Atlas Weathering stated to Craig that they have not received any Heat Shield Capsheet or Heat Shield Tar and Gravel samples from PRI Asphalt.

In our original contract with PRI Asphalt and L& L Suppliers, Inc., it states, that there will be a separate charge to L & L Suppliers, Inc. for shipping samples to 3 year exposure test farm. We never received that bill.

Now that our aged testing is 3 and 1/3 YEARS behind our competition, we will choose a new, responsible, qualified, accredited lab and start all over again.

We have turned this matter over to our attorney for his advice and recommendations.

I would like to thank the California Energy Commission for their continued support in the Cool Roofing Field of our Roofing Industry.
