On January 24, 2008, Roseville Electric filed a petition with the California Energy Commission requesting to modify the Roseville Energy Park (REP) Project. The 160 megawatt project was certified by the Energy Commission on April 13, 2005, and began commercial operations in November 2007. The facility is located in the City of Roseville, in Placer County.

DESCRIPTION OF PROPOSED MODIFICATION

The proposed modification in the petition would allow Roseville Electric to operate the project at the higher permitted NO_x emissions limit. The project owner is requesting the Energy Commission remove conditions associated with the Energy 2001 and Sacramento Air Quality Management District (SAQMD) Bank NO_x Emission Reduction Credits (ERCs) and replace them with a condition that allows the use of Volatile Organic Compound (VOC) ERCs for NO_x, in a manner previously stipulated in the Decision. This request is based on the fact that no NO_x ERCs can be obtained from Energy 2001 because that facility has not created the anticipated NO_x emission credits. The SAQMD Bank does not have sufficient quantities of NO_x credits available to satisfy the needs of the REP facility.

ENERGY COMMISSION REVIEW PROCEDURES

The purpose of the Energy Commission's review process is to assess the impacts of this proposal on environmental quality, public health and safety. The review process includes an evaluation of the consistency of the proposed changes with the Energy Commission's Decision and if the project, as modified, will remain in compliance with applicable laws, ordinances, regulations, and standards (Title 20, Calif. Code of Regulations, section 1769). Energy Commission staff is currently analyzing the request and will publish an analysis in the next several weeks. A public hearing for the purpose of approving or denying the amendment proposal will subsequently be held at a regularly scheduled Energy Commission business meeting.

This Notice of Receipt is being mailed to interested parties and property owners adjacent to the project site who may want to participate in the amendment process.


