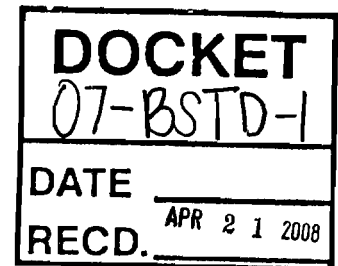


Notice of Hearing

Background

The California Environmental Quality Act , Public Resources Code, Sections 21000, et seq. (hereinafter "CEQA"), requires the Energy Commission to identify and consider the environmental impacts that may occur as a result of adopting revisions to the existing building standards (Title 24, Parts 1 and 6). Energy Commission staff has completed an analysis of the environmental impacts of the proposed 2008 Building Energy Efficiency Standards for residential and nonresidential buildings and outdoor lighting. Issues of air emissions, noise, volatile organic compounds, and materials use were considered. The Initial Study and Environmental Check List prepared by Commission Staff identified no potentially significant impacts on the environment.

Additionally, the Energy Commission sent out a Notice of Intent under section 15072 of the CEQA Guidelines of title 14, California Code of Regulations. The notice provided a public review period from November 16, 2007 to December 23, 2007, which complied with the CEQA Guidelines under section 15073 of not less than 30 days review process. On December 17, 2007 the Energy Efficiency Committee held a hearing to receive public comments on the Initial Study/Proposed Negative Declaration. No comments have been received as of this date disagreeing with Staff's analysis, conclusion, and recommendation. Therefore, staff is recommending that the Commission adopt the Negative Declaration. Staff will prepare under the CEQA Guidelines section 15075 a Notice of Determination, to be filed with the State Clearinghouse five working days after Commission adoption.
