### **Background**

In November 2007, the Energy Commission published a Notice of Proposed Action (NOPA) regarding revisions to the California Building Energy Efficiency Standards, California Code of Regulations, Title 24, Parts 1 and 6. In the NOPA, the Energy Commission listed January 30, 2008, as a proposed adoption date for 45-Day Language for the Energy Efficiency Standards. The NOPA also stated that:



The hearing before the full Energy Commission for final adoption of the 45 Day Language Express Terms will be held on the date below [January 30, 2008] unless the Commission decides to make substantive changes to the Express Terms through 15-Day Language, in which case the public hearing will be continued to a later noticed date ... If the Commission decides to propose 15-Day Language modifications to the Express Terms, separate notice of the adoption hearing for the 15-Day Language will be provided.

This Notice of Hearing serves as the "separate notice of the adoption hearing for the 15-Day Language."

Should the Energy Commission determine that substantial changes to the 15-Day Language are needed, this item will be continued to a future public hearing, a revised set of 15-Day Language documents will be prepared, and the future public hearing will be noticed separately.
