Project Description**

Public Resources Code Sections 25402 and 25402.1 were enacted in 1974 as part of the enabling legislation establishing the Energy Commission and its basic mandates. These sections require the Energy Commission to adopt, implement, and periodically update energy efficiency standards for both residential and nonresidential buildings that are located in Title 24, Part 6 of the California Code of Regulations.

The project subject to the adopted Negative Declaration is the adoption of the 2008 Building Efficiency Standards located in Title 24, Part 6 of the California Code of Regulations. This project focuses on several key areas to improve the energy efficiency of new buildings, including making substantial changes intended to clarify or expand existing requirements for residential buildings and nonresidential buildings and to add requirements for refrigerated warehouses.
