COMMITTEE SCHEDULING ORDER

On March 19, 2008, the City of Riverside (Applicant) submitted an Application for a small power plant exemption (SPPE) to the California Energy Commission in connection with its proposal to construct and operate the Riverside Energy Resources Center Units 3 & 4 (RERC 3 & 4). This proposed gas-fired peaking project has a capacity of approximately 95 MW and is an expansion of the existing Riverside Energy Center Units 1 & 2, a 96 MW peaking facility, which was granted a small power plant exemption by the Commission in 2004 (Docket No. 04-SPPE-1) and began operation in June 2006. With the addition of proposed Units 3 & 4, the power plant would have a nominal generating capacity of approximately 191 MW. Commercial operation is planned to begin by the summer of 2009.

The Energy Commission designated a Committee of two Commissioners to conduct proceedings on the SPPE. The Committee conducted a public site visit and informational hearing on May 12, 2008, to discuss the schedule and other issues of concern. The attached Committee Schedule is based on Applicant's and Staff's proposed schedules and related discussion at the informational hearing.

The schedule covers the period leading up to the Prehearing Conference. The balance of the schedule will be finalized at the Prehearing Conference.

The briefs shall discuss the legal basis for exempting a proposed addition of 95 megawatts by Units 3 & 4 to an existing power plant of 96 megawatts, Units 1 & 2 of the RERC. Is the proposed Riverside Units 3 & 4 project potentially eligible for exemption as a Small Power Plant because it is less than 100 MW, or is it ineligible for exemption because the RERC facility will exceed 100 MW with the addition of Units 3 & 4? The Committee is particularly interested in a discussion of the factual planning background for the RERC in order to aid the Committee in determining whether the RERC should be
