



Group Intervenor object and oppose the motion by the applicant to reopen the evidentiary hearing for the purpose of conducting undefined tests at in Nevada and Colorado to repeat their otherwise objectionable helicopter flyover test with a fixed wing aircraft.

Group Intervenor join in the oppositions by Intervenor Alameda County and by CEC Staff. As to the alleged prejudice which the applicant contends they suffered procedurally, specifically the testimony of Gary Cathey, attached is a true and correct copy of the sign-in sheet for the Sept. 2007 proceedings in the RCEC action before the full Commission at which Mr. Cathey appeared and opposed the amendment to RCEC, however, the evidentiary hearing was closed so that his statements were precluded as admitted evidence. (Counsel can provide a declaration if the hearing officer so requests.)

This sign in sheet reflects that in addition to counsel for applicant EEC being present, so were the principal Greg Truitt as well as representatives from CH2MHill. Further, Group Intervenor request administrative notice of the reporter's transcript for the Sept. 2007 proceedings filed in the RCEC proceeding. This reflects that Mr. Cathey's opinion was no surprise but disclosed as early as September 2007.
