# **REVISED COMMITTEE SCHEDULING ORDER**

 On July 31, 2008, the Committee assigned to conduct proceedings on the Application for Certification (AFC) for the CPV Sentinel Project (Sentinel) held a status conference to discuss the progress of the project and future scheduling.

The Committee produced the following accelerated schedule at the urging of the Applicant with the concurrence of Energy Commission Staff. All parties acknowledged that the failure to obtain a Final Determination of Compliance (FDOC) by the designated date will postpone the entire schedule accordingly. Also, the Applicant requested and the Staff joined in the request to set the Committee Conference on the Presiding Member's Proposed Decision (PMPD) eleven days prior to the closing of the 30-day comment period. The parties acknowledged that subsequent public comment might necessitate another Committee Conference on the PMPD which may cause further delays in the schedule. Nevertheless, the Applicant has expressly accepted that risk.
