Laurie – It has been awhile since we spoke about this project. The client has decided to change the project to avoid all jurisdictional waters and wetlands by utilizing horizontal boring. In June 2008 we submitted the Application for Certification (AFC) to the California Energy Commission (CEC) for the Orange Grove project. As part of the AFC process we have received data requests from the CEC. One of the data requests included the following:

Please confirm that the USACE has reviewed the project description and Appendix 6.5-B of the AFC and concurs that a Section 404 permit will not be required for horizontal direction drilling beneath six jurisdictional drainages.

We would appreciate if you could send an email letting us know that the USACE does not permit horizontal boring since there will not be any cut or fill activities associated with the project within jurisdictional waters.
