

NOTICE OF RECEIPT PETITION TO AMEND THE ENERGY COMMISSION DECISION for the HENRIETTA PEAKER PROJECT (01-AFC-18C)



On October 10, 2008, GWF Energy LLC (GWF) filed a petition with the California Energy Commission requesting to modify the Henrietta Peaker Project (HPP). The 95-megawatt project was certified by the Energy Commission on January 31, 2002, and began commercial operation on July 1, 2002. The facility is located adjacent to PG&E's 70 kV Henrietta Substation approximately one mile south of Highway 198 on 25th Ave southeast of the town of Lemoore in Kings County.

DESCRIPTION OF PROPOSED MODIFICATION

The modification proposed in the petition would involve converting the existing HPP from a nominal 95-megawatt (MW) simple-cycle power plant into a combined-cycle power plant with a nominal 25 MW (net) of additional generating capacity. Though the plant would be renamed the GWF Henrietta Combined-Cycle Power Plant (GWF Henrietta), it will retain the capability to operate in a simple-cycle configuration. New once-through steam generators (OTSGs) would be installed to allow the plant to be operated in its current simple-cycle configuration with no steam generation but with the selective catalytic reduction (SCR) and oxidation catalyst in operation. The proposed change would also enable the facility to operate as a combined-cycle power plant generating an additional 25 MW (net) of power with new proposed emission limits.

ENERGY COMMISSION REVIEW PROCEDURES

The purpose of the Energy Commission's review process is to assess the impacts of this proposal on environmental quality, public health and safety. The review process includes an evaluation of the consistency of the proposed changes with the Energy Commission's Decision and if the project, as modified, will remain in compliance with applicable laws, ordinances, regulations, and standards (Title 20, Calif. Code of Regulations, section 1769). Energy Commission staff is currently analyzing the request and will publish an analysis in the near future. A public hearing for the purpose of approving or denying the amendment proposal will subsequently be held at a regularly scheduled Energy Commission business meeting.

This Notice of Receipt is being mailed to interested parties and property owners adjacent to the project site who may want to participate in the amendment process.
