INTRODUCTION

The California Unions for Reliable Energy ("CURE") submits this third status report pursuant to the Committee's August 29, 2008 Status Report and Schedule.

DISCUSSION

CURE is carefully evaluating the AFC's discussion of environmental impacts for the Avenal Energy Project. CURE submitted data requests to the project applicant seeking information concerning a number of issues including greenhouse gas emissions, air quality impacts, soil contamination, traffic impacts, biological impacts and transmission engineering. CURE also submitted comments on the Preliminary Determination of Compliance issued by the San Joaquin Valley Air Pollution Control District.
