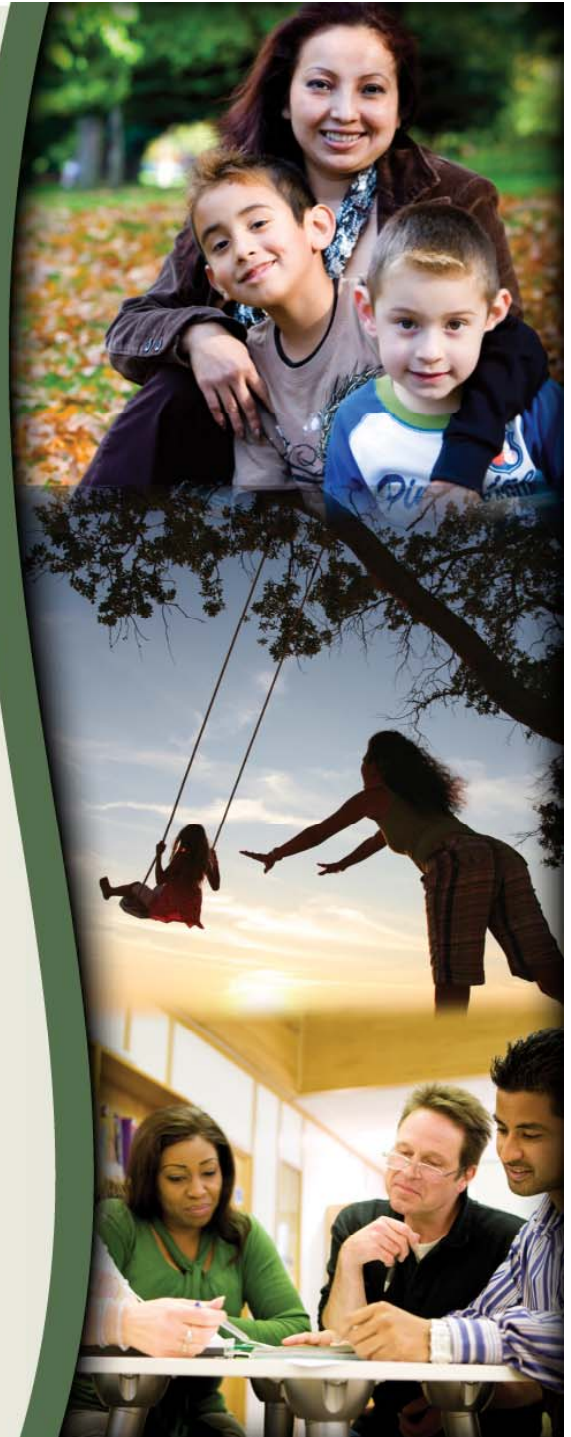

### Making your voice heard

- Blue Cards: Verbal Comments at Public Meetings
- Written Comments or Statements to the Commission Dockets Unit (Docket No. 08-AFC-07)

### Comments

- Considered by the Commissioners
- Part of the record
- Not evidence



# Two Levels of Public Participation

The Public Adviser's Office

## Formal Participation (Intervenor)

### How to Formally Participate

- Contact the Public Adviser's Office
- File Petition to Intervene

### Who can Become and Intervenor

- Anyone may file a Petition to Intervene in a proceeding
- You do not have to be or have an attorney to intervene
- The petition is considered by the assigned committee
- If approved, you become a party to this proceeding

# Two Levels of Public Participation

## Benefits & Responsibilities to Intervening

Intervenors have the same rights and responsibilities as other parties

Receive

- All filings in a case, including AFC
- Notices of hearings and workshops through Proof of Service

Fully participate in the process of obtaining information

File documents and serve them on all parties

- Motions
- Petitions
- Objections
- Briefs

Present evidence and witnesses

Cross-examine witnesses provided by other parties
