#### **Purpose**

California Energy Commission staff recently filed its MNDIS on the Riverside Energy Resource Center Units 3 & 4. The purpose of this MNDIS workshop is to receive comments on staff's analysis from the applicant, public, interveners in the proceeding, and local, state and federal agencies. Discussions will include all topics contained in the NDIS with a focus on: Air Quality, Biology, Soil and Water and Waste Management. Public comments on the NDIS are welcome and encouraged to be submitted in writing by December 4, 2008, to Felicia Miller, Project Manager, at the address on this letterhead.

#### **Background**

On March 19, 2008, the City of Riverside filed an application for a Small Power Plant Exemption (SPPE). The City of Riverside, proposes to build, own, and operate two simple cycle units at its Riverside Energy Resource Center (RERC) within the City of Riverside, Riverside County. The proposed gas-fired peaking project would have a nominal generation capacity of approximately 95 megawatts (MW) and would be an expansion of an existing 96 MW peaking facility exempted by the Energy Commission in 2004. RERC Units 1 & 2 began operation in June 2006. RERC Units 3 & 4 would supply internal peaking power to meet the needs of the City of Riverside primarily during summer peak electrical demands.

The proposed project site is owned by the City of Riverside and is located adjacent to and on the east side of the City of Riverside's Regional Water Quality Control Plant in a light industrial/manufacturing area. RERC Units 3 & 4 would be located immediately north of Units 1 & 2 and would occupy approximately 2.2 acres of the 16-acre RERC site. The remaining rough-

graded, undeveloped portion of the RERC site would be used for construction laydown (approximately five disturbed acres in total).

The Energy Commission is responsible for reviewing, and ultimately approving or denying, all thermal electric power plants, 50 MW and greater, proposed for construction in California. The Energy Commission's SPPE process allows projects between 50 and 100 MW to proceed with local approval through a mitigated negative declaration process rather than obtaining Energy Commission certification. An exemption is available if the Energy Commission finds that the project would not create a substantial adverse impact on the environment or energy resources. If an exemption is granted, the applicant would need to secure the appropriate licenses and permits for the project from various local, state and federal agencies.


