

Background

AB 118 created the Alternative and Renewable Fuel and Vehicle Technology Program. The legislation authorizes the Energy Commission to spend approximately \$120 million per year for over seven years to develop and deploy irnovative technologies that transform California's fuel and vehicle types to help attain the state's climate change policies. AB 118 directs the Energy Commission to develop sustainability goals.

To date, the Energy Commission has hosted numerous public workshops, to solicit stakeholder responses to staff's development of the sustainability concepts and framework that will be used to implement AB 118.

Purpose

This meeting is to test and discuss the sustainability framework concepts developed for AB 118 as presented in the draft staff paper AB 118 Sustainability Goals and Characteristics: An Integrated Framework for Assessing the Sustainability of AB 118 Project Applications. Several stakeholders will present case studies of potential projects in the context of the sustainability framework, including regulatory goals, thresholds and sustainability characteristics. Professor Stephen Kaffka, from the University of California at Davis and California Biomass Collaborative, will participate on the case studies. The meeting will also begin discussion on how to use the sustainability characteristics as potential evaluation criteria for the Solicitation phase of the AB 118 program. Staff is seeking comment on how to develop a ranking or weighting system.
