APPLICANT'S STATUS REPORT #6

The following discussion summarizes the status of the Ivanpah Solar Electric Generating System ("Ivanpah SEGS") Application for Certification [07-AFC-5] proceeding since the issuance of Applicant's Status Report No. 5 on December 5, 2008.

Applicant is filing today its comments on the Preliminary Staff Assessment. Applicant has spent considerable time and resources over the holidays and in early 2009 to provide detailed comments intended to facilitate the production of the joint FSA/DEIS.

Applicant is aware that Staff seeks certain "deliverables." Rather than debating whether all of the requested materials are necessary at this juncture of the licensing proceeding, Applicant is working diligently on these matters. Applicant notes that only a few subject matter disciplines are affected by these requested deliverables. Accordingly, the materials requested should have no material effect on schedule for production of other sections of the joint FSA/DEIS.
