

The plans for a **Silicon Valley Based CNG Demonstration Center** were presented at the recent public hearing in San Jose on Feb. 11, 2009. This memo is to provide a document for the public record of our intent to propose such demonstration project using AB118 funding.

Mission: To demonstrate the effective use of Compressed Natural Gas from a Large Fueling Station to multiple type vehicles such as Pickups, Taxis, Shuttle Buses and Transit Buses for other Fleet Managers. To implement a **CNG Demonstration Center** to better educate Fleet Managers in California as to the very positive aspects of utilizing CNG and CNG vehicles to reduce Dependency on Foreign Oil, reduce Emissions and reduce Fleet Fuel Costs.

Team: The San Jose Airport, Silicon Valley Clean Cities, Silicon Valley Edition, Synergy, and the City of San Jose would develop a Promotion and Training Program allowing Fleet Managers from California to come to Norman Mineta San Jose International Airport to review the CNG Fueling Station and see a variety of Vehicles running on CNG.



CNG Demonstration Center, continued

To leverage the current CNG Fueling Center, the Taxis, Pickups, Shuttles and Buses that fuel effectively every day to teach other Fleet Managers how to implement such a green vehicle program.

The Demonstration Center could include Video Promotion, Website, Visitation Days, Classrooms, Program Management, Corporate Fleet Packages, and Financing of other CNG project implementation.

Estimated cost of Demonstration Center is between \$300,000 and \$600,000, depending on the vehicles, training offered, and support services offered.
