## Purpose

This joint committee workshop is to discuss transportation fuel infrastructure issues confronting California including production, delivery, distribution, and storage as well as the adequacy of California's supply of petroleum and alternative fuels. Specific topics include:

- Crude Oil Infrastructure – Preliminary crude oil import forecast and potential expansion of the existing Petroleum Reserve to the Western States.
- Marine Terminals – Adequacy of existing offloading and storage facilities to handle growing volumes of crude oil, petroleum, and renewable imports over the forecast period.
- Distribution Terminals – Adequacy of existing facilities to store and dispense growing volumes of renewable fuels over the forecast period.
- Retail Stations – Increased use of renewable fuels will require adequate development of the retail station infrastructure, including storage tanks and dispensers, acknowledging that supply and vehicle populations are necessary and interrelated elements.
- Petroleum Product Pipelines – Regional and California projects and issues that could impact petroleum product pipeline infrastructure.

The workshop is intended to be a forum in which to receive input from industry stakeholders and the public on the issues and related policy concerns. A staff workshop was held in Sacramento on February 10, 2009, which discussed methods, data, and assumptions highlighting the transportation fuel price forecasts. The information from these workshops will be used in the development of the *2009 IEPR*.

## Background

As required by Senate Bill 1389 (Bowen, Chapter 568, Statutes of 2002) the Energy Commission conducts "assessments and forecasts of all aspects of energy industry supply, production, transportation, delivery and distribution, demand, and prices." In addition, the Energy Commission conducts workshops to receive input from the public and industry stakeholders to develop energy policies that conserve resources, protect the environment, ensure energy reliability, enhance the state's economy, and protect public health and safety. Public Resources Code PRC § 25302(a) and (d) directs the Energy Commission to adopt the IEPR every odd-numbered year and in even-numbered years an energy policy review is conducted to update analyses from the previous IEPR or to raise energy issues that have emerged since the previous proceeding.
