## ENERGY COMMISSION STAFF'S COMMENTS REGARDING SCHEDULING IN THE AVENAL ENERGY PROCEEDING

On March 13, 2009, the Committee overseeing review of Avenal Power Center, LLC's Application for Certification (AFC) for Avenal Energy scheduled a Committee Status Conference for March 23, 2009, to discuss progress on the AFC and comments from the parties. On February 27, 2009, staff submitted its Avenal Energy Status Report 4, in which it indicated its intention to file the Final Staff Assessment (FSA) in early April.

Shortly after the status report was filed, the Committee overseeing the Greenhouse Gas Emissions of Power Plants proceeding (08-GHG OII-1) released its report entitled, "Committee Guidance on Fulfilling California Environmental Quality Act (CEQA) Responsibilities for Greenhouse Gas Impacts in Power Plant Siting Applications." The report discusses the issues involved in analyzing greenhouse gas emissions in power plant siting cases and identifies areas for further investigation. Staff has reviewed this report and plans to do additional work on staff's greenhouse gas analysis of Avenal Energy in accordance with the guidance contained in the report. A key piece that will aid in this analysis is a technical report that will assess greenhouse gas emissions in the context of California's integrated electric system. Staff believes that this report will provide helpful information concerning how new projects such as

Proof of Service (Revised  $\frac{2/3}{3}$ ) filed with original. Mailed from Sacramento on 3-9-09. Avenal Energy will impact the emissions of greenhouse gases on a system-wide basis. Staff expects to have the report completed by the end of April and would need some time to incorporate the report's findings into the Avenal Energy FSA. Therefore, staff asks that the Committee, if it must set a deadline for the FSA, set it for June 1, 2009. Based on this deadline, staff recommends the hearing schedule proceed as follows:
