

All of the following information considered to be confidential has been prepared by qualified consultants and has not been disclosed to any other party.

All of the information in **Appendix C** from the Orange Grove Project Cultural Resources Monitoring and Mitigation Plan (CRMMP) is confidential. Appendix C includes two (2) cultural resource location maps. These depict the locations of previously known and newly recorded or updated archaeological sites. The information depicted on these maps was derived from survey work and record searches. All information garnered from record searches was transmitted by the South Coast Information Center of the California Historical Resources Information System (CHRIS) and submitted to the qualified consultant according to the terms of a confidentiality agreement, as required by all Information Centers of the CRHIS. These maps were prepared for TRC and submitted to the California Energy Commission.

2. State and justify the length of time the Energy Commission should keep information or data confidential.

The above referenced figures should be kept confidential in perpetuity. If the descriptions of the locations of the sites are released to the public domain, there is risk of looting or other acts of vandalism to the cultural resources identified.

3(a). State the provision(s) of the Public Records Act (Gov. Code § 6250 et seq.) or other law that allows the Energy Commission to keep the information or data confidential, and explain why the provision(s) apply to that material.

The above referenced figures identify site locations and areas of potential American cultural significance. It is thus protected under Government Code Section 6254 (r).

If the material contains trade secrets or its disclosure would otherwise cause loss of a competitive advantage, please state how it would be lost, the value of the information to the applicant and the ease or difficulty with which the information could be legitimately acquired or duplicated by others.

The public interest will be served by nondisclosure by preventing looting of the cultural resource sites described in the above referenced figures. Such looting would preclude scientific study of the sites to obtain data about the cultural resource areas.


The above referenced figures cannot be disclosed in whole, or in any part (e.g. masked) in order to protect sensitive cultural resources.






