

subject: GWF TRACY COMBINED CYCLE POWER PLANT PROJECT (08-AFC-7) STATUS REPORT #4

Pursuant to the Committee Scheduling Order dated October 31, 2008, the following is Staff's Status Report #4 for the proposed GWF Tracy Combined Cycle Power Plant Project (GWF Tracy).

Staff has been working through the analysis phase of the Application for Certification (AFC) process for the proposed GWF Tracy Project. With the exception of one area, staff are finalizing their Preliminary Staff Assessment (PSA) sections. The PSA section for Air Quality is still pending.

Air Quality

The San Joaquin Valley Air Pollution Control District (SJVAPCD) will be issuing their Preliminary Determination of Compliance (PDOC) in the end of March or early-April. The Energy Commission's Air Quality staff will complete work on their PSA section after the PDOC is issued.

Schedule

The PSA was scheduled to be filed on February 12, 2009, with a PSA Workshop scheduled to be held on February 26, 2009. Due to the delays, these dates are being postponed. A more specific timeline will be proposed after the PDOC is issued.
