

# NOTICE OF RECEIPT

#### PETITION TO CHANGE OWNERSHIP FOR THE MOUNTAINVIEW GENERATING STATION PROJECT (00-AFC-2C)

On April 1, 2009, the California Energy Commission received a petition from Mountainview Power Company, LLC, requesting approval to transfer the ownership of the Mountainview Generating Station Project, from Mountainview Power Company, LLC, a wholly owned subsidiary of Southern California Edison, to Southern California Edison Company.

The 1,056-megawatt project was certified on March 21, 2001, and began commercial operation on January 19, 2006. The facility is located in the City of Redlands, in San Bernardino County.

### **ENERGY COMMISSION REVIEW PROCEDURES**

A statement describing the change in ownership, signed under penalty of perjury by a representative of the proposed new owner of the project, was submitted to the Energy Commission staff for review and approval as required by Title 20, California Code of Regulations, section 1769(b). The statement affirms that the new owner agrees to be bound by the requirements of the Energy Commission's Decision for the Project and understands the obligations imposed by the Conditions of Certification. Based on the information provided, staff intends to recommend the proposed change be approved by the Energy Commission at the June 3, 2008 business meeting.
