COMMITTEE HEARING ORDER ON SCE CONFIDENTIALITY APPEAL

Southern California Edison Company (SCE) requested confidentiality for certain data submitted on Electricity Demand Forms in this proceeding. On March 27, 2009 the Commission's Executive Director granted the request in part and denied it in part. On April 10, 2009 SCE filed a timely appeal to the Commission, challenging the denial of confidentiality for the following information on Form 1.2 – Distribution Area Net Electricity for Generation Load:

Losses for 2008 - 2011
Total Distribution System Energy Requirements for 2008 - 2011
Forecast Net of Uncommitted Impacts for 2008 - 2011
Forecast Gross of Uncommitted Impacts for 2008 - 2011
Average Annual Growth Rate (%) for 2007 - 2012

The Commission will conduct the appeal as an adjudicative proceeding under the Administrative Procedure Act. (Gov. Code, tit. 2, div. 3, pt. 1, ch. 4.5, § 11400 et seq.; see also Cal. Code Regs., tit. 20, §§ 1220 - 1217.) SCE and the Commission Staff (and any intervenors) are parties, and the schedule is:

- May 1 Parties shall file and serve prehearing conference statements, summarizing their positions, describing the types of evidence necessary to address the issues, and briefly discussing the provisions of the Public Records Act and other laws that allow or require the Commission to grant confidentiality for the specific data at issue in the appeal.
- May 4 Prehearing Conference. This will take place at the Energy Commission and begin at 9:00am. The conference should last no more than 15 minutes. The previously-scheduled Joint IEPR/Siting Committee Workshop will immediately follow.
- May 11 Parties shall file and serve opening testimony.

- May 18 Parties shall file and serve rebuttal testimony.
- May 21 Evidentiary Hearing. This will be held at the Energy Commission and will begin at 1:00 p.m. Each party's counsel may make opening and closing statements of no more than 2 minutes each. Each party's witnesses shall have an aggregate total of 5 minutes, per party, to summarize their testimony orally. Each party shall have an aggregate total of 20 minutes, per party, for cross-examination of all of the other party's witnesses.
- June 1 SCE (and any intervenors supporting SCE) shall file opening brief(s).
- June 8 Staff (and any intervenors supporting Staff) shall file responding brief(s).
- June 12 SCE (and any intervenors supporting SCE) shall file reply brief(s).
- June 19 Committee issues draft decision.
- June 26 Parties shall file comments on draft decision.
- July 1 Commission hearing and decision (Business Meeting).

In addition to other any other filing or service required by the Commission's regulations, the parties shall serve all documents by e-mail on all other parties, the IEPR Committee and the advisers thereto, and Assistant Chief Counsel Jonathan Blees.
