Subject: **San Gabriel Generating Station (07-AFC-2) STATUS REPORT 5**

Pursuant to the Committee Scheduling Order dated July 12, 2007, the following is staff's Status Report 5 for the proposed San Gabriel Generating Station (SGGS).

Preliminary Staff Assessment (PSA)

Felicia Miller met with technical staff in January to discuss the possibility of publishing a PSA. All PSA sections are complete, with the exception of the Air Quality section, which needs additional language to address recent green house gas regulations and the Preliminary Determination of Compliance (PDOC) from SCAQMD that is no longer current. It was determined that because the project is unable to secure the necessary offset credits with SCAQMD, no PSA would be filed at this time.

Project Manager Transition

On April 2, 2009, the project was reassigned from Ivor Benci-Woodward to Felicia Miller as Project Manager.

South Coast Air Quality Management District (SCAQMD) Permitting Issue

A Superior Court ruling was issued in July 2008, resulting in SCAQMD's Priority Reserve Program no longer being available as a source of air emission offset credits for power plants under our review process. SCAQMD sent letters in February 2009 to each power plant applicant proposing use of Priority Reserve Credits asking for information on their current plans for obtaining sufficient offsets.

Following phone contact with the applicant during the first week of May, staff will be sending a letter Reliant Energy and its subsidiary, San Gabriel Power Generation, LLC asking them to provide information within 30 days on how they intend to move forward in the Commission's licensing process.
