

# Joint Integrated Energy Policy Report and Siting Committee Workshop on Transmission Planning Process/Strategies Refinement and Corridor Information Development

The California Energy Commission's (Energy Commission) Integrated Energy Policy Report (IEPR) Committee and the Siting Committee will conduct a joint workshop to describe the results of the Renewable Energy Transmission Initiative (RETI) Phase 2A work, solicit feedback on how the RETI collaborative process can be leveraged to achieve a coordinated statewide transmission planning process, solicit feedback on strategies for the development of a long-term statewide strategic plan for California, and identify corridor designation opportunities arising from the RETI Phase 2A results. Commissioner Jeffrey D. Byron is the Presiding Member of the IEPR and the Siting Committees. Vice Chair James D. Boyd is the Associate Member of the IEPR Committee. Chairman Karen Douglas is the Associate Member of the Siting Committee. ### Purpose

This workshop will contribute to the development of the Energy Commission's 2009 Strategic Transmission Investment Plan (2009 STIP). It will continue the dialog begun at the May 4 joint IEPR/Siting Committee Workshop on transmission planning information and policy actions. The workshop will cover: (1) Presentation on the Renewable Energy Transmission Initiative (RETI) Phase 2A results; (2) panel discussion on achieving a coordinated statewide transmission planning process, using a strawman proposal<sup>1</sup> as a starting point; (3) panel discussion on the development of a long-term statewide strategic transmission plan for California; and (4) identification of corridor designation opportunities from RETI Phase 2A results.

### Background

The June 15, 2009 Joint IEPR and Siting Committee workshop is the second Committee-level workshop that responds to the IEPR Committee's January 9, 2009, Committee Scoping Order for the 2009 IEPR<sup>2</sup>, which directs the 2009 STIP to address the following topics:

- 1. Identify and evaluate regulatory or policy changes that will reduce barriers to transmission projects, including joint investor-owned and publicly owned utility projects.
- 2. Identify specific near-term transmission projects that will ensure reliability, relieve congestion, provide increased access to renewable generation, and meet future growth. This will include a discussion of system improvements needed to reduce local capacity requirements for fossil-fuel generation.
- 3. Discuss federal and state corridor designation efforts to identify potential transmission corridors in advance of need to streamline future permitting of transmission lines needed to access top priority renewable resource zones.
- Discuss current transmission-related research and development and future efforts needed to help resolve transmission barriers, including the use of smart grid technologies.

The first joint IEPR/Siting Committee workshop for the 2009 STIP was held on May 4, 2009. That workshop covered the development steps for the 2009 STIP and relevant transmission information from a variety of sources, including the responses received

from transmission-owning load serving entities to the Commission's *Forms and Instructions for Submitting Electric Transmission-Related Data.*<sup>3</sup> It also provided the opportunity for the joint committees to solicit feedback from stakeholders on actions needed to overcome barriers to renewable transmission projects and corridor development.
