REVISED COMMITTEE SCHEDULING ORDER

On January 28, 2009, the Application for Certification (AFC) was deemed data adequate for the twelve-month review process consistent with Public Resources Code, section 25540.6. The Committee conducted a public Informational Hearing on March 12, 2009, to discuss the schedule and other issues of concern, and issued a *Committee Scheduling Order* on March 23, 2009.

Since that time, both Staff and Applicant have encountered circumstances which warrant revision of the schedule. Staff has indicated that it needs further time to develop and analyze information related to data requests it has submitted to the Applicant, and the Applicant has obtained an extension from the Yolo-Solano Air Quality Management District (YSAQMD) of the deadline for submitting its emissions offset package.

Therefore, we are issuing the attached **Revised Committee Schedule**. It accommodates the delays encountered to date and adjusts future deadlines accordingly, and it requires more frequent status reports in order to bring potential schedule delays or other relevant matters to our attention.


