APPLICANT'S STATUS REPORT NO. 2

In accordance with the Committee Scheduling Order dated May 7, 2009, San Joaquin Solar 1 LLC and San Joaquin Solar 2 LLC, collectively referred to as San Joaquin Solar or "Applicant", submits its second status report in this proceeding.

Responses to Staff Data Requests

The Staff's proposed schedule and the Committee Scheduling Order called for Staff to issue its first set of Data Requests on April 20, 2009. Staff issued its first set of 148 data requests on April 30, 2009 (Data Requests 1-148).

The Applicant responded to 28 requests on May 20, 2009. The Applicant responded to an additional 62 data requests on June 1, 2009 (30 days after receipt of the Staff's data requests).

The Applicant filed objections to 9 data requests on May 20, 2009. On June 12, 2009 the Applicant and Staff met and conferred regarding the Applicant's objection to these data requests from Staff. As a result of our meeting, the Applicant and Staff have reached agreement regarding the acceptable level of response to each of these data requests. The agreement is summarized in a letter to the Committee dated June 23, 2009.

The Applicant is working expeditiously to complete its response to the outstanding 58 data requests. The Applicant expects to respond to all outstanding data requests from the Commission Staff on or before July 15, 2009. (Please note that Staff's Status Report 1 erroneously stated that the Applicant had requested an extension of time to respond to 112 data requests. In fact, only 58 responses are remaining.)

Response to CURE's Data Request

On May 28, 2009, California Unions for Reliable Energy (CURE) submitted Data Request Set One (Nos. 1-2) to the Applicant. The Applicant responded to CURE's data request on June 18, 2009.

Conclusion

San Joaquin Solar believes that the proceeding is progressing satisfactorily.
