On May 4, 2009, the Department of Fish and Game ("Department") received your Notification of Lake or Streambed Alteration ("Notification"). This Notification was submitted in draft form for Department feedback in anticipation of meeting the requirements pursuant to the Lake and Streambed Alteration Agreement ("Agreement") process as described in the Fish and Game Code Sections 1600 et seq. Agreements associated with the Project will ultimately be issued by the California Energy Commission ("CEC") pursuant to the Warren Alquist Act. Although the CEC will issue any Agreements required, the substantive criteria in the Fish and Game Code must be met. The Department is assisting CEC in determining the scope and nature of the Agreement and will be providing CEC with recommendations to this effect.

On May 11, 2009, the Department determined that your Notification is incomplete because the information checked below is either missing or insufficient. To complete item number 4, please include fees for each individual stream crossing. Each of the two (2) crossings is considered a separate "Project" for the purpose of calculating fees (please see the Notification instructions at http://www.dfg.ca.gov/habcon/1600/forms.html).

To complete item number 5, please include a map showing the two (2) locations where the proposed access road would cross the streambed. Although the application references a location map titled "Figure 1," no maps or figures were included with the application. The application also references a CD which was not included with the application.

To complete item number 6, please indicate the ½-section(s) in which the stream crossings are proposed.

To complete item number 7, please describe the type of material which would be placed in the streambed, including any headwalls, endwalls, or bank protection to keep the proposed sand and gravel fill from eroding during creek flows. The application references a "Figure 2" and site photographs which were not included with the application.

To complete item number 8, please send the Department plans which detail each proposed stream crossing structure, including a plan view, elevation, and cross section with dimensions.

For item 11, please describe the permanent measures proposed to prevent the sand and gravel fill from eroding into the stream. The application describes only temporary construction measures for erosion control.

For item 15, please describe explain the purpose of constructing permanent stream crossing structures to serve a temporary construction access area. The Department would prefer that structures installed for temporary construction access are removed upon Project completion.

Please note that you may not proceed with your Project until your Notification is deemed complete, and you have obtained a Lake or Streambed Alteration Agreement, if required. If you have any questions regarding this matter or need additional information, please consult the "Notification Instructions" and/or "Questions and Answers" that were included in the notification materials.
