Purpose

This workshop will discuss with stakeholders the Energy Commission's schedule and proposed funding areas for the EECBG and SEP programs to be administered by the Energy Commission. The workshop will also offer stakeholders an opportunity to learn about the proposed guidelines and funding areas for both programs. The funding areas include green workforce development; California Department of General Service's energy efficiency retrofits for state buildings; use of the Energy Commission's existing Energy Conservation Assistance Act (ECAA) account for low interest rate loans (1 percent) for local jurisdiction energy saving projects; grants for energy saving projects, a clean energy program to support combined heat and power systems, distributed generation and energy product manufacturing; and energy efficiency retrofits for commercial and residential facilities.

Background

On June 3, 2009, the Energy Commission adopted an order instituting an informational proceeding to gather information to develop guidelines that will govern the administration and award of federal funds received pursuant to ARRA.

ARRA provides \$787 billion nationally in economic investment to stimulate the economy and create jobs. The Energy Commission is administering two programs (and possibly more in the future), the EECBG for \$49.6 million and the SEP for \$226 million.

The guidelines focus on the Energy Commission's implementation of the EECBG Program and the SEP and describe program objectives, eligibility requirements and limitations, available funding, evaluation criteria, and administrative procedures that apply to funding. The Energy Commission will consider approval of the final guidelines at a Business Meeting in September, 2009.

The Energy Commission's guidelines are part of a public process in coordination with the state's energy agencies, local governments, utilities, interested stakeholders, and members of the public. To the extent possible, the guidelines have been developed on an expedited basis consistent with the purposes of ARRA and Governor Schwarzenegger's Executive Order S-02-09, which created the Federal Economic Stimulus Task Force.
