MORE EECBG PROGRAM INFO

The U.S. Department of Energy (DOE) deadline for their initial program application for EECB Grants funding activities for state energy offices has been extended to June 25, 2009. This response to DOE is only for large cities and counties and tribal governments that will receive direct DOE allocations and the California Energy Commission who is administering the EECBG program for small cities and counties. The Energy Commission's guidelines and application process for small cities and counties has NOT been developed yet. Updates regarding the Energy Commission's EECBG program process will be noticed through the ListServe and available on the recovery web site www.energy.ca.gov/recovery

SMART GRID CAPS INCREASED

May 18, 2009: U.S. Commerce Secretary Gary Locke and U.S. Energy Secretary Steven Chu announced significant progress that will help expedite development of a nationwide "smart" electric power grid. Early last month, the Governor, the Energy Commission and others submitted letters requesting changes to DOE's draft Funding Opportunity Announcement funding levels for the Smart Grid. California specifically called to increase the caps for individual projects to allow for larger utility Smart Grid projects and asked for higher levels of funding to support Smart Grid demonstrations. DOE responded favorably by increasing the maximum award for the Smart Grid Investment Grant Program from \$20 million to \$200 million and increasing funding awards for the Smart Grid Demonstration Projects from \$40 million to \$100 million. CARBON SEQUESTRATION CAPTURES BIG MONIES

May 15, 2009: DOE will be posting Notices of Intent for funding that will advance RD&D in these areas of Carbon Capture and Storage Projects: Industrial Carbon Capture & Storage (\$1.52 billion) for a competitive solicitation for large scale CCS from industrial sources to focus on beneficial CO2 reuse and CO2 capture from the atmosphere (this includes \$20 million to a facility in Washington state and \$70.6 million to a host facility in Arizona); Clean Coal Initiative (\$800 million) to expand new coal technologies; Geologic Sequestration Site Characterization for competitive solicitations to differentiate 10 geologic formations in the US (\$50 million); and Geologic Sequestration Training and Research focusing on educating and training future generation of geologists (\$20 million). http://www.fossil.energy.gov/news/techlines/2009/09029-DOE_Announces_Stimulus_Funding.html
